Cookpad Inc. (the "Company") hereby announces that its Board of Directors today resolved to present a resolution seeking approval of "Partial Changes to the Articles of Incorporation" at the 20th General Meeting of Shareholders, to be held on 28 March 2024.

1. Purposes of the amendment

(1) To enhance the productivity and operational efficiency of its officers and employees through the improvement of the office environment for better business growth, the Company plans to relocate its headquarters. Accordingly, we will propose that the officially registered location of the headquarters stated in Article 4 of the current Articles of Incorporation should be changed from Yokohama, Kanagawa Prefecture, to Meguro-ku, Tokyo.

Subject to shareholder approval, this change will take effect on 1 May 2024, and for clear communication of the timing of the change, we will add a supplementary provision, which will be removed after the effective date of the change.

- (2) To facilitate the orderly progression of the General Meeting of Shareholders, we will propose that an amendment to the Articles of Incorporation to permit the appointment of a co-chair to serve alongside the chair in presiding over the meeting.
